## **OLD BUSINESS**

### **Banquet**

Overall, banquet was a success and was enjoyed by attendees:

- 183 attendees
- Net loss of approximately \$1800 for the event. Food cost was biggest expense.
- Better signage/promotion of silent auction?
- Audio was difficult to hear. Cardinal Room's audio was down so the DJ's speakers had to be used, which was not optimal.
- 2024 Banquet tentatively booked for 1/4/2025

- Invitations: Some members reported that they did not receive invites. Only one invitation
  was returned as undeliverable, unsure how other invites were delayed/lost by USPS. Since
  we already have a date/location for next year, would like to get invites out in November to
  avoid any delays due to December holidays. This would also help to evaluate menu
  options from caterers in order to get the most accurate pricing.
- Program ads: Missed opportunity. Flyers were sent in the invitations, but were missed.
   Recommend having someone to solicit ads (and raffle/silent auction donations) for better response.

### USHJA Annual Meeting Recap

Ms. Schoenlein and Ms. Vaught reported:

- Check out the USHJA Programs, which were all promoted at the meeting:
  - o Recognized Riding Academy and School Horse awards
  - Instructor Credentialing programs
  - Horsemanship Quiz challenge: Study guide and other resources available online
  - o Emerging Athletes Program and Mini EAP Clinics
- Proposed rule changes:
  - A system to "level up" horses and riders to demonstrate proficiency at a skill set before moving to higher and more challenging skills.
  - o Guidelines for when a competitor can approach the Judge
  - o Judges being allowed to change scores after a video review.
  - Stronger position overall on horse welfare, including limiting number of classes that a horse can do in a day, quarantine plan requirements, temperature monitoring including biothermal microchips
  - Zone 10 and Jumper Task Force both recommended rule changes that would eliminate "speed-only" classes for any jumper class below 0.95m (would still allow jump-off classes at these heights) for the safety of the horse and rider.
- Good opportunities for networking during lunch sessions and breaks. Had great discussion during the Equitation working group about medal finals and how other regions execute them successfully.
- Ms. Vaught commented that her biggest takeaway from the meeting was new
  appreciation for how Horsemanship and Equitation are fundamental building blocks for
  the Hunter/Jumper sport, and that we as an organization should focus on promoting those
  foundational skills to set up our riders for future success.
- Ms. Schoenlein recommended that IHJA should send more members to the USHJA Annual Meeting in order to obtain better insight into the governance of USHJA and issues that are facing the sport throughout the country.
- Ms. Stumm asked about the rule change that was approved last year (which went into
  effect this year). Ms. Stumm stated that IHJA needed to include a statement in the IHJA
  Rule Book that was similar. Ms. Vaught agreed to review the USEF and IHJA rules and
  make the appropriate changes to the IHJA Rule Book before we vote on it later in this
  meeting.

# Review of Fine Discussion

Ms. Stumm asked that the Board review the issue of IHJA issuing fines for rule and conduct violations.

- Ms. Stumm has reviewed our decision at the last meeting to impose a fine and felt that we needed to have rules in place before we could impose any fine.
- Ms. Vaught commented that while at the USHJA Annual Meeting, she discovered that USHJA does not impose fines, only USEF, the higher governing body. USEF devotes 9 pages of its bylaws to the complaints and grievances process, including rights of both the individual lodging the complaint and the individual against whom the complaint was made. <a href="https://www.usef.org/forms-pubs/wncxC9gluP4/bylaws">https://www.usef.org/forms-pubs/wncxC9gluP4/bylaws</a>. Without all of these procedural protections in place, Ms. Vaught does not feel that IHJA can impose any fines or suspensions without putting the organization at undue risk.
- Ms. Maclean-Whitaker agreed that she felt that the actions previously taken were adequate for a first offense of this nature.
- Ms. Zirkelbach asked how IHJA would go about adding those rules that were necessary to support IHJA being able to impose a fine. Ms. Vaught stated that a rule change of this magnitude would require the due diligence to perform an in-depth review of the USEF resources, adjusting and adapting them to meet IHJA's needs, and proposing them to be included in next year's rule book.
- Ms. Schoenlein suggested that this topic be approached with extreme caution, because it could put IHJA at risk for litigation, which has been threatened previously and could possibly put the organization at risk of bankruptcy.
- Ms. Maclean-Whitaker, Ms. Heim, and Ms. Zirkelbach will work together on this initiative.

#### **Rule Book**

The 2024 Rule Book has been submitted to the Board to review in advance of the meeting. Ms. Vaught provided a high level overview of the recent changes to the Board.

Ms. Davis made a motion to accept the rule book as presented. Ms. Heim seconded the motion. **The motion passed unanimously.** 

#### **Open Discussion**

- Ms. Vaught suggested that IHJA should develop a "handbook" that encompassed the
  Duties and Responsibilities of the Board and each committee. This document would
  supplement the Bylaws and provide additional information on what each committee is
  responsible for. This document would serve two purposes: to ensure continuity of the
  organization's operations as Board members are elected every two years, and also to help
  identify activities for which volunteers can be recruited to assist.
- Ms. Vaught suggested that IHJA should investigate becoming a 501(c)(3) so that donations
  to our organization would be considered. Ms. Vaught has asked our CPA to start
  investigating what we would need to do in order to be considered an Educational
  organization instead of a Sports Club.
- Membership considerations:
  - Ms. Zirkelbach asked if there is a way to offer discounted membership fees for IEA and ISHA members?
  - Ms. Snodgrass asked if we can we develop a program to encourage trainers to register a large number of lesson horses by offering a more affordable price point?
  - Ms. Vaught stated that the organization needs to consider that membership and horse registration fees help to pay for end of year awards (ribbons and Champion/Reserve prizes), and any adjustments that we make to membership/horse fees should result in an increase in members to compensate for the decrease in revenue so that we can continue to offer the prizes that our members want.
  - Ms. Snodgrass and Ms. Zirkelbach and Ms. Boyle will work together to discuss a plan that can be presented at the next Board meeting.
- In return for the donation of grooming brushes by Wahl, Ms. Vaught asked for photos of their brushes being used that could be submitted back to Wahl in appreciation for their generous donation.
